1. Financial Updates

• \$60k in WF, \$38k in Univest

- Assessment reminder mailer sent 11/1 Have had a few payments come through and following up with more directly. – Collected \$40k in past due multi-year owed accounts.
 Overall down \$30K compared to last year.
- Samuels CDC Grant \$100k lottery will open in January. Adam following up with Samuels contact. Marlo has potential back up interest from Giordano's Garden Grocers and MVP Hauling.
